DECLARATION

I...declare and state as follows:

- 1. I am a resident of California, a United States citizen and am 58 years old. I am of sound mind and body, am not under the influence of any drug or alcohol and make this statement of my own free will under no pressure with respect to its contents.
- 2. I have been a member of the Scientology religion since 1970 and a member of Scientology Church staff as well as the Sea Organization since 1971...
- 3. ... I am writing this affidavit to set forth the truth, from my own personal experiences and observations, having met and worked directly under L. Ron Hubbard, the Founder of Scientology; having worked for many years under Mr. Miscavige, the leader of the Scientology religion today...
- 4. In my career I have worked both in Scientology organizations that directly service public parishioners and as a management executive...
- 5. ...In 1982, I moved to the International Headquarters base in California. I have resided and worked at that location since then. Between 1982 and 1986, when L. Ron Hubbard departed, I had extensive communications with Mr. Hubbard, both in writing and verbally in face-to-face meetings.
- 6. Through a combination of my close relationship with Mr. Hubbard and working under his personal direction, the extensive study I have done over the years of the Scientology Scriptures, as well as my having read thousands of pages of directives, notes and dispatches from Mr. Hubbard, I came to know with a complete certainty what Mr. Hubbard's goals and long-range plans and wishes were with regard to all aspects of the Scientology religion. I also experienced firsthand the warmth and care Mr. Hubbard had for people everywhere and his unceasing efforts to help individuals.
- 7. ...I came to know L. Ron Hubbard intimately.

8. I have known, been close friends with and worked under the leadership of Mr. David Miscavige since 1981. His level of understanding, compassion and care for humanity is like no one I have ever known save for Mr. Hubbard.

- 12. During the time period from 1982 to the present I have received and given hundreds of communications from and to Mr. Miscavige, both written and verbal; I have worked on numerous projects directly under his supervision; I have accompanied him on inspections of Scientology Churches in both the eastern and western United States as well as in the United Kingdom, Germany, France, Switzerland and Denmark; and I have participated in numerous Scientology events at which Mr. Miscavige as well as individual members of Scientology management addressed Church parishioners to brief them on news of Church expansion and activities.
- 13. From my own communications with L. Ron Hubbard as well as having read hundreds of communications between Mr. Hubbard and Mr. Miscavige, I observed that Mr. Hubbard had tremendous confidence in Mr. Miscavige and trusted him implicitly...
- 14. All the briefings and programs, both written and verbal, that I have seen or heard Mr. Miscavige give have been clearly aligned with and aimed at accomplishing the goals and long-range plans Mr. Hubbard had for Scientology. And I know personally that the actions Mr. Miscavige has taken have fulfilled Mr. Hubbard's wishes and carried out his intentions without any alteration, distortion or other agenda whatsoever.
- 15. During my 28-year relationship with Mr. David Miscavige, I have observed him to consistently be helpful and understanding in his relations with other staff members and patient to a fault with those who have difficulty grasping their job. He routinely coaxes others to perform better and to turn out a higher quality product by setting an example of this himself in his own diligence and industry at learning how to do something and taking the care to do it right. Mr. Miscavige's actions toward other staff have consistently been in the direction of

acknowledgment for the work they are doing and helpful encouragement and inspiration for what remains to be done.

16. Mr. Miscavige has been a great friend to me personally, has helped me... more times than I can count and has demonstrated more care and compassion for staff generally than anyone I have known with the exception of Mr. Hubbard himself.

- 19. ...With regard to the former Scientologist(s)...: In the entire time that I knew Rathbun as a Church staff member, which was from 1984 until he deserted the Church in 2004...he chronically fouled up legal and other external matters he was meant to handle...He routinely acted like a bully towards his fellow staff members... Marty Rathbun's behavior was irrational and bizarre in the extreme... Despite everything, he was still given a chance to straighten himself out and start following the technology and policy as written by L. Ron Hubbard, but he refused. His pretended authority was now gone and he hated it. And, in 2004, he again ran away.
- 20. With regard to...Mike Rinder...I was working directly under L. Ron Hubbard during his research into the root cause of psychosis—evil purposes. This is the factor behind the chronic liar, the home-wrecker, the person who tries to cripple an organization. Near the beginning of that research, the *one* example Mr. Hubbard gave of someone with serious evil purposes was Mike Rinder...
